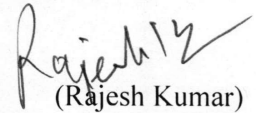

Minutes of the Meeting

As per the discussion of the PAB meeting for the AWP&B 2023-24 for Samagra Shiksha, Ladakh and the visit of Ladakh the team from Ministry of Education & TSG (SamagraShiksha), the UT submitted a supplementary proposal under the Samagra Shiksha, based on specific requirements considering the unique features of Ladakh. Post appraisal of proposals, a supplementary PAB meeting was held on 01.09.2023 under the chairpersonship of Secretary, SE&L. The list of participants is placed at **Annexure-I**.

2. Secretary (SE&L), welcomed the participants to the meeting and Economic Advisor (SE&L) made a presentation on the educational profile, financial status of the UT along with the details of the proposals and recommendations. The following points were discussed during the meeting:

3. The UT profile was discussed, financial status was reviewed and the conditions for release of funds were reiterated. Director (Finance) mentioned since UT is 100% Centrally funded, UT needs to follow Letter of Authorization (LoA) method as per OM of March, 2021 for release of funds.

4. The access component related matters were also discussed. A district wise assessment was shared with the UT for mapping the school requirements based on population & GIS mapping. UT informed that schools are available in most areas specified in the gap assessment, however the same was not mapped on GIS platform. UT was asked to ensure updation of GIS based on the latest UDISE+ data.

5. Following this, the team shared the feedback regarding the visit to Ladakh and informed the officials regarding their observations such as improvement required in sanitation facilities in schools, internet provision in ICT labs and smart classrooms, shortage of teachers (specially in Kargil district), additional heating provisions especially for the residential schools/hostels, completion of student/teacher registry and marked improved learning levels of students at foundational stage etc. The team will share the detailed report with the UT for further deliberation and action areas.

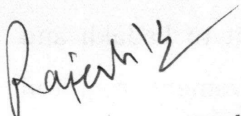

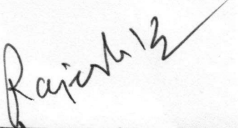
