ADDENDUM

Subject: Annual Work Plan & Budget (AWP&B) for the year 2025-26 for the State of Maharashtra – Supplementary Project Approval Board (PAB) meeting held on 28.05.2025- Revision of the Minutes of the Meeting of the Project Approval Board (PAB) held on 04th March, 2025 -reg

The undersigned is directed to refer to this Department's letter of even number dated 02.05.2025 whereby the Minutes of PAB meeting of Samagra Shiksha, Maharashtra was circulated. A Supplementary Project Approval Board (PAB) meeting was held on 28.05.2025 to consider saturation of provisions related to ICT Labs, Smart Classrooms, and subject-specific laboratories, in accordance with the programmatic norms of Samagra Shiksha.

2. Pursuant to the deliberations of the meeting, an amount of Rs. 14443.1 lakh was approved for the State of Maharashtra for the establishment of ICT Labs, Smart Classrooms, and Science Laboratories in government secondary schools under the Samagra Shiksha scheme. This has necessitated revision of the minutes issued vide OM No. 10-212025-IS.1 dated 02.05.2025 in order to reflect the total approval accorded in the PAB meeting held on 04.03.2025 as well as in the supplementary PAB held on 28.05.2025.
