B. Appraisal of Current proposal for ICT labs & Smart Classrooms in Govt. Secondary Schools

The meeting of the **Supplementary Project Approval Board** with regard to ICT labs and Smart Classrooms of Annual Work Plan and Budget (AWP&B) 2025-26 for Samagra Shiksha for the State of Punjab was held on 6th November, 2025 at New Delhi. The list of participants who attended the meeting is at *Annexure-I*.

Shri Sanjay Kumar, Secretary (SE&L), welcomed the participants. A presentation on the implementation of the Status of Samagra Shiksha in Punjab was made. The following are the major action points from the discussions and deliberations during the presentation:

1. School Enrolment Indicator - GER, NER, Dropout & Transition rate

The State deserves to be appreciated for its good achievement in Gross Enrolment Ratio (GER) at all levels. While the Net Enrolment Ratio (NER) needs to be improved at all levels specially at secondary level.

The State is requested to analyse school wise enrolment data as 70.53% Govt schools have only 45.17% students and to ensure appropriate steps are taken to improve dropout rate and transition rate.

2. Infrastructure in Government Schools

There are 18784 works sanctioned during 2018-19 to 2024-25 of which 13433 are completed and 5351 are pending. Out of the 4167-work sanctioned in 2025-26, 4162 are pending. The State is requested to expeditiously complete these works in 2025-26.

The State was requested to update the progress of activities under the *infrastructure* component on PRABANDH portal.

3. Financial Status:

a. Release of Funds:

Two instalments have been released to State and Secretary (SE&L) urged the State to ensure that all four instalments to be drawn during the financial year 2025–26.

b. Expenditure against Approvals

As per the Monthly progress report, The State has incurred expenditure primarily under the following components:

- o RTE Entitlements
- Financial Support to Teachers
- Inclusive Education
- o Programme Management

The State was advised to enhance focus on the following components too:

- o Teacher Education
- o Gender & Equity
- o Access & Retention
- o Quality Interventions
- Skill Education

4. Recruitment of Teachers:

The State informed that recruitment of 8000+ Pre-Primary Teachers in Government schools has been initiated which shall help to improve dropout and retention rates in foundational & primary grades. Pursuant to the deliberations of the meeting, an amount of ₹ 10569.60 Lakhs was approved for the State of Punjab for the establishment of ICT Labs and Smart Classroom in Government secondary schools under the Samagra Shiksha scheme as detailed below:
