Accordingly, an additional sum of Rs. 40.88 lakh is recommended in the appropriate head so that the final approved outlay in Academic assistance through BRC/URC & CRC listed at para. 18 of PAB Minutes will be read as Rs. 11266.40 lakhs instead of Rs. 11225.52 lakhs.

- 3. In PAB 2022–23, funds under MMER have been approved at a rate of 4.5% of the state outlay (Rs 4837.47 lakhs), which is in between the Samagra Shiksha standards of 3.5%–5%. In this regard, it has been informed that the State proposal of 5% of the plan outlay for MMER be accepted, and as a result, para 25 of the PAB minute has been revised to reflect the final outlay approval of Rs. 5394.975 lakhs.
- After taking into account the aforementioned increased funds, the State of Punjab's estimated total budget for 2022–2023 under Samagra Shiksha will increase from Rs. 127494.86 lakhs to Rs. 128093.245 lakhs.
