1. Introduction:

The meeting of the Project Approval Board for considering the Annual Work Plan and Budget (AWP&B) 2023-24 for SAMAGRA SHIKSHA for the State of Goa was held on 17.02.2023 through Video Conference. The list of participants who attended the meeting is at *Annexure - I*.

2. Shri Sanjay Kumar, Secretary (SE&L), MOE welcomed the participants. Goa State was asked to give a presentation on School Education.

Section: I - State Specific Initiatives, Review of Performance & Issues

Sh.Shambhu Ghadi, State Project Director, Goa gave a presentation which included the following major points:

- 2.1 **Industrial Training:** In order to equip NSQF instructors with industrial training the state came up with the provision of five days compulsory industrial training for all the NSQF instructors during summer vacation in which 241 instructors were provided training in 15 sectors.
- 2.2 **School Complex:** School complex is an initiative started by the state to provide academic support to the teachers and through this process schools are covered under school Complex, Super School complex, Taluka level School Complex, Zonal level school complex and State level school complex.
- 2.3 **Special Schools:** Goa state set up 30 Special Schools to provide education to the Special Children. All schools are equipped with required infrastructure and qualified teachers for every disability, paid by the state Govt.
- 2.4 **Robotic Classes:** In order to improve analytical, cognitive, creative and technical aspects of the students, the Goa State Government has initiated coding and Robotics classes for students from std. VI onwards.
- 2.5 **Vidhya Samiksha Kendra:** As part of strengthening evaluation, monitoring system the state government has established Vidya Samiksha Kendra to evaluate and monitor the academic performance of the schools, teachers and Students.

Review of Commitments and Expected Outcomes & Action Taken during 2022-23

3 Review of performance during 2022-23:

- Sh. Vipin Kumar, JS(SS-II) made a presentation on the AWP&B 2023-24 of State of Goa. The copy of PPT is placed at Annexure II.
- 3.1.1 **Gross Enrolment Ratio (GER):** GER has decreased at all levels except for Higher Secondary level from year 2020-21 to 2021-22. State needs to take adequate measures for the GER to increase.
- 3.1.2 **Net Enrolment Ratio (NER):** NER has decreased at all levels from year 2020-21 to 2021-22. State needs to take adequate measures for the NER to increase.
- 3.1.3 **Dropout Rate:** As per UDISE+, annual average dropout rate at primary level has decreased at primary and UP level. However, the dropout rate at secondary level has increased and requires continuous effort on part of Goa to maintain low dropout rate. State needs to continue taking adequate measures to reduce the dropout rate and improve the retention rate.
- 3.1.4 **Transition Rate:** As per UDISE+, Transition rate reveals the percentage of children transiting from one level to another level in a given year. Transition rate has increased at Primary to Upper Primary and Upper Primary to Secondary Level. At upper primary to secondary level it has crossed 100% and at secondary to higher secondary level it is 88.48 % for the current year.
- 3.1.5 **Surplus Teachers at Elementary level:** As per UDISE+ for 2021-22, percentage of schools with adverse PTR decreased from 31.59% to 1.91 % at Upper Primary level. **There are around 330 surplus teachers -** requires redeployment to maintain the PTR as prescribed by RTE Act. State needs to go for rationalization of teachers to ensure availability of required number of teachers in all schools. **However, State Govt. has stated that the rationalisation has been taken up. The position will get reflected in UDISE+ 2022-23.**

- 3.1.6 **Infrastructure in schools:** Goa has done a commendable work in case of providing basic infrastructure as per RTE in schools. There are 100% schools in state having Boys toilet, girl's toilet, drinking water, electricity and library. There are only 17% schools without playground and 11% Schools without ramps. State needs to focus on providing playground and ramps in schools.
- 3.1.7 **Retention rate:** The retention rate at elementary level in state has increased marginally from 96.66 in 2020-21 to 97.86 in 2021-22. Retention rate at secondary level has decreased from 93.05% to 91.51%. The State has to take initiatives for 100% retention of the children in the education system.
- 3.1.8 Gender parity: Percentage of girl's enrolment has decreased marginally at all levels. Secretary (SE&L) directed the state for taking corrective measures to reduce the Gender Parity gap.
- 3.1.9 Teacher Education-Vacancies:
 - Vacancy of academic positions in SCERT- Vacancy of academic positions in SCERT is 76.66% with only 07 faculties in position as
 against total recommended posts of 30 as per the norms. Vacancies need to be filled on priority.
 - II. Vacancy of academic positions in 01 Functional DIETS is 72% with only 07 faculties in position as against total recommended post of 25. The State needs to prioritize filling up of the vacant posts.
- **3.10 Inclusive Education:** Out of a total number of 3,04,982 students, the number of Children with Disability (CwD) are 4149 (1.36%). Further, out of 1510 Schools, Schools with **ramps** 917 (60.72%), Schools with **Disabled Friendly Toilets** (DFTs):

Boys CwSN Toilet- 87 (5.76%), Girls CwSN Toilet- 79 (5.23%)

3.11 In PAB Meeting issues like opening of SNA account, 26 new vocational schools, 7 science lab, 5% MMER cost and surrender of spill over amount against solar panels were pointed out and also emphasized on providing more flexibility to the state in decision making process and its implementation.

3.12 Issues taken up by the State during PAB

Students studying in the special schools are not covered for the benefits given under Samagra Shiksha. In the State of Goa the School position is as under:

All Govt. Aided schools are paid maintenance grants including salary grants of the staff and building rent by Govt. Only the staffs are appointed by the School Managing Committee with the NOC and the approval from the Directorate of Education. The majority of the students are studying in Govt. Aided Schools available in their vicinity, the facility is provided by the Govt. but they are deprived from the felicities given to the students studying in the Govt. Schools under Samagra Shiksha.

- 3.12 Goa state requested to extend support of Samagra Shiksha to remaining 74% students studying in Aided Schools, so that they can also be part of the system without any discrimination.
- 3.13 The population projected is comparatively high as compared to the actual population in the State. This is affecting GER/ NER of the State.
- 3.14 State raised the issue to increase the Salary of Instructors under VE from Rs. 23,000/- p.m. to Rs. 25,000/- p.m.

4.1 Actual Releases by GOI during 2023-24

Against the above estimates, Central Government shall provide to the State Government, Rs. 5,279.08 lakh as its share (Rs. 2803.46 lakh for elementary, Rs. 1,847.53 lakh for secondary & senior secondary and Rs. 628.09 lakh for Teacher Education). Goa will also be able to utilise their unspent balances as on 31st March, 2023 for the activities approved in 2022-23 including spill over.

Based on the demand of funds projected for 2023-24, the tentative share of recurring and non-recurring grants is given below:

The Balance of the outlay (i.e. Rs. 1,770.16 lakh) approved under Non-recurring components in previous years which is not spent fully, is the outlay saved/spill over for the subsequent year (i.e. 2023-24). Against the above Spill over, the committed liability of Department of SE&L is Rs. 856.19 lakh (Rs. 341.67 lakh for Elementary, Rs. 143.62 lakh for Secondary and 370.90 lakh for Teacher Education) keeping in view the total approvals and grants were already released.

Non-recurring grant will be released against the committed liabilities and the fresh approvals subject to the production of required documents by State/UTs and physical and financial progress of these interventions under the non-recurring head.

As per Section 7(5) of the RTE Act, 2009, the State Government shall after taking into consideration the sum provided by the Central Government above and the mandatory matching State share, provide the balance funds necessary to fulfil the estimate for the implementation of the Act. The interventions under the Samagra Shiksha comprise of activities pertaining to Elementary, Secondary and Teacher Education respectively and there is a single Budget for Samagra Shiksha in the Demand for Grants (BE) 2023-24. The release of funds would be from a single Budget Head only. However, for purposes of ascertaining the quantum of funds going to each component, the Sub-Heads for Elementary (including Teacher Education) and Secondary Education has been classified separately.

The State should invariably provide Single Budget Head during 2023-24 and the nomenclature should be Samagra Shiksha. Since Samagra Shiksha would be catering to various activities relating to RTE entitlements and all other Elementary interventions as well as Teacher Training and activities for BRCs and CRCs which forms the portion of Teacher Education activities as well as for Secondary Education, the States shall also provide a suitable Nomenclature with Sub-Heads to identify the disbursement of funds separately under all components of Samagra Shiksha. Fund flow to SCERTs, DIETs etc. will be through State Nodal Account of State Implementing Society only.

4.2 Spill Over

An outlay of **Rs. 1770.16 lakh** as Spill over under various activities falling under Elementary Education, Secondary Education and Teacher Education was estimated with the condition that all pending activities should be completed during this year 2023-24. The detail is enclosed at **Annexure - III**.

5. Costing Sheet

The consolidated item-wise estimate for 2023-24 is at **Annexure - IV.** The State must bifurcate the annexed costing sheet among all the Districts according to their proposals/approvals and capture the district wise expenditure against the budget allotted, on the PRABANDH portal on a monthly basis for the real time monitoring of each activity/component approved under Samagra Shiksha. Also, State needs to ensure that timely implementation of the various interventions as per the annual calendar of activities is submitted.

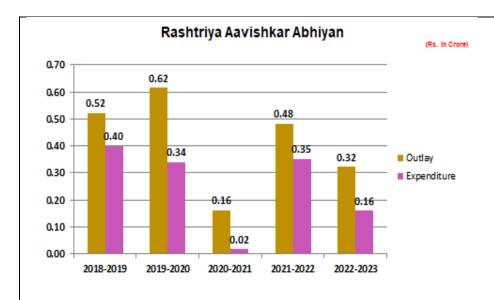












Issues/Concern

ISSUES

- Students studying in the special schools are not covered for the benefits given under Samagra Shiksha.
- Dropout Rate Reducing the dropout at Secondary Level which was at 10.2% during 2021-22.
- State PGI 2021-22 data entry: Data entry Completed, data yet to be approved by SPD.
- As per UDISE+ for 2021-22, percentage of schools with adverse PTR decreased from 31.59% to 1.91% at Upper Primary level.

 There are around 330 surplus teachers.)
- Retention rate at secondary level has decreased from 93.05% to 91.51%. The State has to take initiatives for 100% retention of the children in the education system.
- Percentage of girl's enrolment has decreased marginally at all levels
- Out of a total number of 3,04,982 students, the number of Children with Disability (CwD) is 4149 (1.36%). Further, out of a 1510 Schools, Schools with ramps - 917 (60.72%), Schools with Disabled Friendly Toilets (DFIs) Boys CwSN Toilet- 87 (5.76%) and Girls CwSN Toilet- 79 (5.23%)

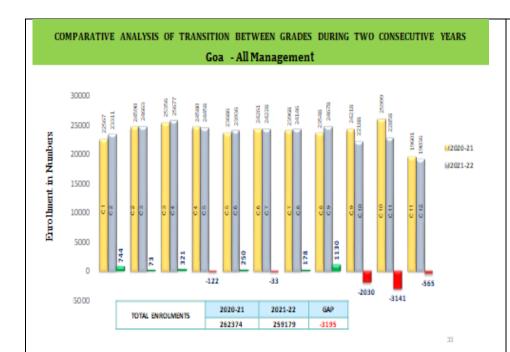

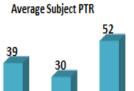
Average Subject PTR

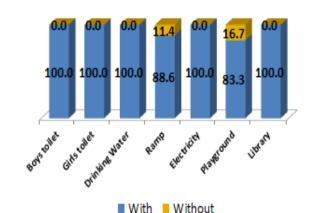
