**ADDENDUM**

**Subject: Addendum to the PAB minutes of Samagra Shiksha, Ladakh for considering Annual Work Plan & Budget (AWP&B) for FY 2025-26- reg.**

The undersigned is directed to refer to this department's letter of even no. dated 14.05.2025 whereby the Minutes of the PAB meeting of Samagra Shiksha, Ladakh for FY 2025-26 was circulated.

2. A Supplementary Project Approval Board (PAB) meeting was held on 28.05.2025 to consider saturation of provisions related to ICT Labs, Smart Classrooms, and subject-specific laboratories, in accordance with the programmatic norms of Samagra Shiksha.
3. Pursuant to the deliberations of the meeting, an amount of INR 186.80 lakh was approved for the UT of Ladakh for the equipment for Laboratories in government secondary schools under the Samagra Shiksha scheme.
4. Further, an amount of INR 1411.20 lakh for DIET Center of Excellence was approved to the UT in the meeting of the Project Approval Board held on 11th April and 6th May 2025 to consider the Annual Work Plan & Budget (AWP&B) 2025-26 of DIETs under Second Phase of DIETs of Excellence scheme under Samagra Shiksha.
5. This has necessitated revision of the minutes issued dated on 14.05.2025 (copy enclosed) in order to reflect the total approval accorded in the PAB meeting held on 17.04.2025 as well as in the supplementary PAB held on 28.05.2025 and also approval under DIETs of Excellence.




