**Subject:- Revision of the Annual Work Plan & Budget (AWP&B) 2025-26 of Samagra Shiksha for the State of Bihar.**

The undersigned is directed to refer to this Department's communication of even number dated 08.05.2025 forwarding therewith the Minutes of the meeting of the Project Approval Board (PAB) held on April 01, 2025 to consider the Annual Work Plan & Budget (AWP&B) 2025-26 of Samagra Shiksha for the State of Bihar.

2. Subsequently, a Supplementary PAB Meeting was held on 28.05.2025, the PAB approved an additional work plan of Rs.240011.21 Lakh, for ICT Labs, Smart Classrooms, and Subject-specific Labs, over and above the work plan of Rs. 982955.42 Lakh communicated earlier on 08.05.2025. Accordingly, details of the revised work plan of Rs. 1222966.63 Lakh (including spillover) was conveyed vide communication of even number dated 03.07.2025.

3. Parallelly, PAB for second phase of DIETs as Centre of Excellence was held and minutes were issued by IS-20 Section vide communication No.22-2/2025-IS.20 dated 22.05.2025. For the State of Bihar, the PAB has approved **Seven (07) DIETs as Centre of Excellence with an estimated cost of Rs. 9613.53 Lakh.**

4. Further, vide letter No. EFE/423/2018-19/Part-II/4026 dated 20.6.2025 & 28-8-2025 State of Bihar, requested **inclusion of spill over amount of Rs. 5080.00 Lakh** relating to NR activities yet to be completed **under Teacher Education** component (including 5015.31 Lakh for development of 6 DIETs as Centres of Excellence approved in FY 2023-24) in AWP&B 2025-26 of Bihar under Samagra Shiksha. This amount was not included in the spillover proposal of the State for FY 2025-26 earlier.

5. In view of the above, approval of the competent authority has been obtained to revise the Annual Work Plan & Budget (AWP&B) 2025-26 of Samagra Shiksha for the State of Bihar to the following extent: -

## 2. Releases by GOI during 2025-26

Against the above estimates, the Central Government will provide, to the State Government, Rs. 5,98,434.02 Lakh during the year 2025-26 as its share (Rs. 3,79,085.44 Lakh for Elementary Education, Rs. 2,09,913.40 Lakh for Secondary Education and Rs. 9,435.18 Lakh for Teacher Education). The State shall contribute Rs. 3,98,956.01 lakh as its matching share. State will also be able to utilize their unspent balance as on 31.03.2025 for the activities approved for 2025-26 including spillover.

Based on the demand of funds projected for 2025-26, the tentative share of recurring and non-recurring grants is given below:
