A supplementary meeting of the Project Approval Board (PAB), for considering the proposal for release of funds to the State of Tamil Nadu for 'RTE Entitlements' component of Samagra Shiksha, in compliance with Orders dated 10.06.2025 of Hon'ble Madras High Court in Writ Petition No. 18427 of 2025 [V. Eswaran vs. Government of Tamil Nadu & Ors.], was held under the chairmanship of Shri Sanjay Kumar, Secretary, Department of School Education & Literacy (DoSEL) on 22.08.2025. The list of participants who attended the meeting is at Annexure-I.

- 2. Shri Sanjay Kumar, Secretary (SE&L) welcomed the participants and asked Dr. Amarpreet Duggal, Joint Secretary (C&M), DoSEL to make a brief presentation including the need for convening supplementary meeting of the PAB.
- 3. The PAB was informed that for the FY 2024-25, Annual Work Plan & Budget (AWP&B) for an amount of Rs. 430566.06 lakh was approved under Samagra Shiksha for the State of Tamil Nadu. Out of this an amount of Rs. 215159.61 lakh was approved as Central share. However, central share could not be released to the State Government of Tamil Nadu during the financial year 2024-25.
- 4. In the meantime, Writ Petition No. 18427 of 2025 [V. Eswaran vs. Government of Tamil Nadu & Ors.] was filed before the Hon'ble Madras High Court as a Public Interest Litigation (PIL) seeking directions to the Government of Tamil Nadu to initiate the process of admission under Section 12(1)(c) of the Right of Children to Free and Compulsory Education (RTE) Act, 2009 for the academic year 2025-26. Hon'ble Madras High Court pronounced its judgement on 10.06.2025. Notable observations / directions of Hon'ble High Court are as under:
 - a. The State Government has the primary responsibility under Section 7(5) of the Act to be responsible to provide funds for the implementation of the provisions of the Act. Therefore, the State Government is directed to make reimbursements by adhering to the timeline laid down in the statute.
 - b. Non-receipt of funds from the Union Government cannot be cited as a reason to wriggle out of this statutory obligation.
 - c. It is true that implementation of the Samagra Shiksha Scheme is aligned to NEP 2020. But then, obligation under RTE Act is independent by itself. Section 7 of the Act states that the Central Government and the State Governments have concurrent responsibility for providing funds for carrying out the provisions of the Act.
 - d. We, therefore, direct the Central Government to <u>consider</u> de-linking the RTE component of SSS and disburse the funds accordingly.

As directed by the Hon'ble Madras High Court, this Department considered the issue and decided to implement the aforesaid Order dated 10.06.2025.

- 5. As per the Programmatic and Financial Norms of Samagra Shiksha, based on which detailed costing sheet of the AWP&B is prepared, 'RTE Entitlements' include six (06) subcomponents, namely, (a) Special Training of Out of School Children (OoSC), (b) Community Mobilization including Training of SMC/SMDC, (c) Free Uniforms, (d) Free Textbooks, (e) Support to SCPCR, and (f) Reimbursement towards expenditure incurred for admission under Section 12(1)(c) of the RTE Act, 2009. However, expenditure under these sub-components is 'Recurring' in nature, and not carried forward to subsequent financial year. Therefore, approval of the PAB is required in order to facilitate release of central assistance, against the recurring expenditure incurred in 2024-25, in the current FY 2025-26.
- 6. Initially approved outlay for 2024-25, actual expenditure by State Government of Tamil Nadu as per information received from the State Government, admissible amount in respect of aforesaid 'RTE Entitlements' are as under: -

- 7. After considering the relevant facts and figures as brought out above, the PAB decided to approve the amount mentioned in column (d) of the Table under Para-6 above and to include in the AWP&B of current FY 2025-26. The PAB also approved that admissible Central Share on the amount mentioned in column (d) of the Table under Para-6 above may be released in the current FY 2025-26 in one go as the State has already incurred the expenditure.
- 8. Accordingly, the revised Annual Work Plan & Budget (AWP&B) 2025-26 of Samagra Shiksha for the State of Tamil Nadu and release by Government of India during 2025-26 will be as under: -

(2) Actual release by GoI during 2025-26

Against the above estimates, Central Government shall provide to the State Government, Rs. 221003.052 lakh (Rs.184722.384 Lakh+Rs.36280.668 Lakh) as its share: Rs. 159663.816 lakh (Rs. 123383.148 lakh+ 36280.668) lakh for Elementary education, Rs. 54604.50 lakh for Secondary education and Rs. 6734.736 lakh for Teacher Education. The State would contribute Rs. 147335.368 lakh (Rs.123148.256 lakh+24187.112 lakh) as its matching share. State will also be able to utilize their unspent balances as on 31.03.2025 for the activities approved for 2025-26 including spill over. The details of central share under recurring and non-recurring grants are as given below:
