**REQUEST FOR QUALIFICATION-II (RFQ-II) FOR SETTING UP OF MODEL SCHOOLS UNDER
PUBLIC-PRIVATE PARTNERSHIP (PPP) MODE**

The Model School Scheme of the Ministry of Human Resource Development, Government of India aims to set up 2,500 model schools under PPP mode as benchmark of excellence in blocks other than Educationally Backward Blocks (EBBs) at the rate of one school per block. This Ministry had previously invited proposals from private entities through an advertisement published in July, 2012 for setting up of 500 such schools in the first phase of the Scheme. This Ministry has selected 41 blocks for award of model schools in the pilot phase of the scheme. The details are available on the Ministry's website www.mhrd.gov.in. The Ministry of Human Resource Development, Department of School Education and Literacy now invites proposal from interested private entities for qualification to set up such model schools for remaining 459 blocks of the first phase.

The RFQ-II may be obtained between 1100 hrs to 1300 hrs and 1400 hrs to 1600 hrs from Facilitation Counter of this Ministry, situated at Ground Floor, Shastri Bhawan, Dr. Rajendra Prasad Road, New Delhi-110115 on all working days on payment of a fee of Rs. 10,000/- (Rupees Ten Thousand only) in the form of a demand draft drawn on any Scheduled Bank in India in favour of PAY AND ACCOUNTS OFFICER, MINISTRY OF HUMAN RESOURCE DEVELOPMENT, NEW DELHI, payable at NEW DELHI. The RFQ can also be downloaded from http://mhrd.gov.in/msup_eng. (Downloaded form will have to be submitted along with the DD of Rs. 10,000/-).

Those private entities which have been shortlisted in the pilot phase (details available on the Ministry's website www.mhrd.gov.in), their applications will be valid, applicable and binding for this Bid process and shall be deemed to be part of this Application. Applicants may, however, update their Applications or provide additional information, as necessary and as per the provisions of the RFQ. They need not submit the requisite fee of Rs.10,000/- along with their proposal.

Last date for submission of PROPOSAL is **15th October, 2013 upto 1100 hours IST**. Sealed envelope earmarked to the captioned address, containing proposal may be submitted mentioning the following:
