As you are aware that the Department of School Education and Literacy, Ministry of Education is implementing Samagra Shiksha, a centrally sponsored scheme, effective from 2018-19, in coordination with all States/UTs. Community Mobilization is one the provisions under Quality and Innovation component of Samagra Shiksha.

2. Community mobilization and close involvement of community members in implementation of School Education is extremely critical as it fosters 'bottom-up approach' not only in effective planning and implementation of interventions in the schools but also in effective monitoring, evaluation and ownership of the government programs by the community. Constitution of School Management Committee (SMC)/School Management Development Committee (SMDC) in Schools is one of the provisions of Community mobilization component of Samagra Shiksha.

SMC/SMDC is required to be constituted in every school at the start of the academic session which includes representative of local authorities, academicians, subject experts, officials, representative of disadvantaged groups, women and parents/guardians of students, in accordance with section 21 of RTE Act.

3. As reflected in the UDISE+ 2021-22 (copy enclosed), only 82.41% elementary schools and 74.77% secondary schools have constituted SMCs/SMDCs. As the new academic session 2024-25 is about to start, I would like to request you to issue necessary instructions regarding constitution of functional SMCs/SMDCs in all schools, in accordance with section 21 of RTE Act and ensure that schools are organizing SMC/SMDC meetings regularly and members of SMC/SMDC are participating in the meetings actively.

Further, a format has been developed to collect the latest status of SMCs/SMDCs in all States/UTs. You are requested to share the status of SMCs/SMDCs in your State/UT in the prescribed format (copy enclosed) by 10th April, 2024.
